## Directors' Report

The condensed consolidated statement of profit or loss and other comprehensive income has been extracted from the Group's unaudited accounts for the nine months ended 30 September 2020 and for its comparative period in 2019 (unaudited), and has been approved by the Board of Directors on 15 October 2020.

### Principal Activities

Endo Ventures Ltd (the 'Company') was incorporated on 11 June 2018 under the terms of the Companies Act (Cap. 386 of the laws of Malta). The Company was formed principally to serve as the ultimate holding company of the Endo Group.

The Endo Group consists of Endo Ventures Ltd (C 86730) as the parent company, and its direct and indirect subsidiaries, including:

Endo Finance plc (C 89481), the issuer of €13.5 million 4.5% Unsecured Bonds 2029;

The Guarantors, namely International Fender Providers Ltd (C 69877) and IFP International Fender Providers Ltd (a company registered under the laws of Cyprus with company registration number HE 348221), both providing ship-to-ship services in Malta, Augusta and Cyprus, and Endo Properties Ltd (C 13033), owning a number of properties in Malta valued at  $\leq$  10.2 million; and

Endo Tankers Ltd (C 88663) and its sub-group consisting of Intership Management Ltd (C 74524), Endo One Maritime Ltd (C 88665), Endo Two Maritime Ltd (C 88666), Endo Three Maritime Ltd (C 88674), Endo Headwind Maritime Ltd (C 93341), and Endo Tailwind Maritime Ltd (C 93340).

The objective of the Endo Group is to acquire, finance, manage and charter commercial vessels, in addition to providing ship-to-ship services.

Endo Tankers Ltd, through Endo Three Maritime Ltd, has recently acquired vessel MT Endo Sirocco, which is the third vessel to be added to its existing fleet consisting of MT Mumtaz owned by Endo One Maritime Ltd and MT Endo Breeze owned by Endo Two Maritime Ltd.

### Performance Review

The Endo Group generated revenue of  $\notin$ 7,286,002 for the nine-month period ended 30 September 2020 (2019: Revenue of  $\notin$ 3,929,384). Comparison with prior year needs to be taken into the context that operations of some of the Endo Group's subsidiary companies did not commence from the beginning of the year in 2019, and only started after the bond issue by Endo Finance p.l.c., and were fully operational as from the third quarter 2019. In fact, revenue for third quarter 2020, amounting to  $\notin$ 2,061,287, is more or less in line with the same quarter in 2019 ( $\notin$ 2,035,951).

During the nine-month period under review, the Group's profit amounted to  $\notin$ 756,845 (2019: Profit of  $\notin$ 239,058), whereas profit for the third quarter amounted to  $\notin$ 231,386 compared to  $\notin$ 225,539 in the previous year's same quarter.

The Group's activities are expected to remain consistent for the foreseeable future.
